Oregon Community Solar Program Eligible Customers by Utility



Subscribers in the Oregon Community Solar Program are classified as residential, small commercial, and large commercial/industrial/irrigation customers based on their utility rate schedule. This document provides a mapping of utility rate schedule to Community Solar Program (CSP) customer type for each of the three participating utilities.

Customers on certain utility schedules are not eligible to participate in the Oregon Community Solar program. These include direct access customers, lighting/traffic signal accounts, cost of service opt-out customers, and customers who are receiving volumetric incentive rates (VIR) under the Solar Photovoltaic Volumetric Incentive Program. Ineligible schedule types are indicated in the table below.
